Dear Ms. Barkley:

In confirmation of our telephone conversations regarding your letter dated December 6, 1995, I wanted to respond to the concerns raised in your letter regarding contributions in excess of \$200 per calendar year.

As we discussed, the North Jersey PAC's 1995 Mid-Year Report refers to only one contributor whose contribution exceeded \$200 for the calendar year and for whom the employer and occupation information is missing. In accordance with our standard procedure, a follow-up letter was sent to the contributor requesting the missing information. The North Jersey PAC uses its "best efforts" to obtain the required information, and in that regard, I am enclosing copies of the PAC's standard solicitation material and follow-up letter, which, among other things, clearly indicate that the reporting of such information is required by federal law.

I hope that this information addresses the concerns raised in your letter as to contributions in excess of \$200 per calendar year. However, if I can be of any further assistance or
