- 2. The \$1,000 contribution received by the Committee on June 27, 2000 from the Micro Warehouse Political Action Committee was earmarked for "Friends of Harry Reid," and forwarded to the Reid campaign, via Committee check, on the same day. The entry on Page 7 for Line 11c of the Committee's Report which states that the referenced contribution was earmarked to Frist 2000, Inc. is an inadvertent error. An amended Page 7 for Line 11c is attached.
- The Committee's disclosure of contribution refunds received from Donnelley for Congress was properly disclosed on Line 16.
