
In your letter of August 9 you referenced our only contribution of \$2500 to a federal candidate as being in excess of our authority to contribute. That was also confirmed by the candidate's office and they refunded the amount to our PAC Fund this month. A copy of the refund check is attached. We will report the refund in our next quarterly report.

Also attached is the Federal Election Commission Form 1M requesting qualification for multicandidate status. When we receive confirmation of our multicandidate status, we plan to reissue a check to the candidate.

As you can see on the Form 1M, we were qualified within the criteria in October 1998. However, we were not aware this additional form needed to be filed. Considering that the Plasterers' Local 8 has always been diligent in meeting its filing and other requirements, we hope you will not invoke any penalties for this oversight.
