
The following are the explanations as requested by your letter dated June 11, 2008.

Paragraph 2 requests clarification of Line 11(a)(i) which were receipts labeled "State of Texas" and "Texas Comptroller." These were amounts sent to our party from the Secretary of State to use for expenses incurred in the primary election process.

Paragraph 3 requests clarifying information regarding the source of the transfer received by this committee. This transfer was moneys sent to our county by the "Republican Party of Texas" for district-wide candidates. These are candidates who were on our local ballot, but because of a multi-county district did not reside in this county. The money was collected by the State and then disbursed to the counties who were similarly affected by the multi-county election.
