Dear Mr. Decker:

This letter is in response to your above referenced correspondence regarding incomplete or incorrect information contained in our Quarterly Reports for the periods ending March 31, 2005 and June 30, 2005. I have responded to each of your comments below.

-The Quarterly Report for the period ending March 31, 2005 was amended on January 31, 2006 to include Schedule H1 prior to receiving your correspondence and again on February 10, 2006 in order to provide or clarify other information that your review found to be missing. As part of Amendment 3, we have added clear descriptions for administrative expenses. In general, shared expenses included shared office telephone usage, office supplies, and other overhead expenses. The Committee did not engage in any Federal Election Activity during this period.

We are aware of the need to disclose non-monetary contributions and have none to report during the two periods in reference.

- -The totals shown during these periods on Line 30(b) were the result of a clerical error when entering the information into our reporting database. The Committee does not employ any full-time staff but rather relies on consultants and independent contractors. Further, the Committee did not engage in any Federal Election Activity during this period, therefore the requirement to pay salary and wages with only Federal funds would not apply. Please see the appropriate adjustments on the amended reports filed February 10, 2006.
- -Aggregated totals on Schedule H4 have been corrected. During the two periods in reference there were no joint Federal/Non-federal events or activities and therefore the aggregated totals on Schedule H4 reference only Administrative cash disbursement totals year-to-date.
- -Included in the amendments already filed for the periods in reference are brief descriptions of each itemized disbursement. With regard to the specific description Voter Registration , the expense was incurred for supplies used in connection with general Party activity in the City of San Francisco where the Committee endeavors to register voters as part of its Mission as a local Party Committee.

As Treasurer of the San Francisco Democratic County Central Committee, I am personally committee to ensuring that the Committee adheres closely to all provisions of the Act and that the public is provided with full disclosure regarding our federal election campaign finances. We are, however, a small Committee raising less than \$100,000 annually. We are primarily involved in local city and county political campaigns and rarely engage in any attempt to influence Federal Elections except as our local goals overlap with those of the National Committee as in such areas as voter registration, voter identification and GOTV. It is because of these specific activities that we are a registered Committee and report

these activities as appropriate. Although our reports during these periods included several technical errors, there was no attempt or intention to withhold information from the general public.
