-Schedule H4 of your report discloses lump sum payments to NYRSC Staff Salaries for payroll purposes; however, you have not itemized the individuals who receive payment. Each person who provided services to the committee must be identified if the payments made through the payroll account to the ultimate payee exceed \$200 in a calendar year. Please amend your report by providing the name, date, amount, and purpose for such payments as required by 11 CFR §102.9(b)(2)(i)(A).

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
