Dear Ms. Sugarman,

This statement is in response to the Commission's letter dated December 14, 2014. The Commission requested additional information regarding three items.

First, regarding differences in the totals on the Detailed Summary Pages of Line 11(c) and the entries itemized on Schedule A, the differences constitute unitemized contributions. Those contributions will be itemized on an Amended report so that the totals on the Detailed Summary Pages match the totals of itemized contributions on Schedule A. Additionally, on the same Amended report, the Committee will include the contribution from the American Association of Clinical Endocrinologists, INC. PAC AACEPAC (C00368365) on line 11(c) instead of line 11(a) as originally reported. The contribution was reported on 11(a) by mistake from "AACEPAC, Inc." The contribution came from the federally registered PAC (C00368365). The 11(c) total is now \$54,150.

Second, the Commission requested clarification regarding two contributions that were reported on Schedule A of the Committee's 30 Day Post-General Report (10/16/2014 - 11/24/2014). The contribution from John Kilgallon was reported on a 48 Hour Notice but was mistakenly reported coming from Gerard H. Killenberger instead. (See TRANS ID F6.18618). Gerard H. Killenberger did not make a contribution of \$1,000 on 10/23/14. The 10/23/14 48-Hour Notice will be amended to reflect the donor for that contribution as John Kilgallon. Additionally, the contribution from Rajan Gulati was reported on a 48 Hour Notice but was mistakenly reported with the wrong amount. (See TRANS ID F6.18645) The contribution from Rajan Gulati should have been reported as \$2,500, not \$1,000. The correct amount will be reflected on an Amended 10/26/14 48 Hour Notice.

Third, as discussed in Item 2, the \$1,000 contribution on 10/23/14 originally reported from Gerard H. Killenberger was actually from John Kilgallon which does appear on Schedule A of the report (See TRANS ID SA11AI.19046). The 10/23/14 48-Hour Notice will be amended to reflect the donor for that contribution as John Kilgallon.

The Committee believes that this response and the accompanying amendments will answer the Commission's inquiry. Please feel free to contact us if you have any further questions.
