This letter is prompted by the Commission's preliminary review of the report referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **Failure to adequately respond by the response date noted above could result in an audit or enforcement action.** Additional information is needed for the following 2 item(s):

1. Your amended report discloses an increase in receipts totaling \$12,500 from the amounts disclosed on your original report. Please amend your report or provide clarifying information as to why this activity was not disclosed on your original report. (11 CFR § 104.3)

2. Schedule D of your report itemizes debts owed to "Young, Todd," "Broghamer Consulting LLC," "EC Consulting, LLC," "OORAH! POLITICAL ACTION COMMITTEE," and "Socko Strategies, LLC," with outstanding beginning balances not included on your previous report. Please file an amendment to your report(s) to correct this discrepancy. (11 CFR § 104.11(b))

- Your report discloses certain categories of financial activity that have been reflected on the wrong lines of the Detailed Summary Page. For your information and consideration when preparing future filings, offsets to operating expenditures (rebates, refunds, etc) should be properly disclosed on a separate Schedule A, supporting Line 15 of the Detailed Summary Page. **Please note, you will not receive an additional notice from the Commission on this matter.** Adequate responses must be received by the Commission on or before the due



date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**
