Dear Ms. Antoinette:

Please find enclosed a copy of your letter and materials sent to me on April 7, 1999 in which you have raised the question of our treatment of certain contributions to A Lot of People Supporting Tom Daschle and Voinovich for Senate as to whether we have exceeded the \$5,000 limit per election to each of these candidates.

Please be advised that as a result of our review we have determined that certain contributions which we reported as general election contributions were in error and those contributions were in fact for primary elections. Accordingly the following returns are being amended: December 31, 1997 semi-annual report, June 30, 1997 semi-annual report, September 30, 1996 quarterly report, June 30 1995 semi-annual report, and the June 30, 1993 semi-annual report. The following contributions to A Lot of People Supporting Tom Daschle, originally designated as general election are amended to be for the primary election: June 30, 1997 for \$2,000, July 23, 1996 for \$1,000, April 10, 1995 for \$1,000 and June 8, 1993 for \$1,000. The following contributions to Voinovich for Senate, originally designated as general election are amended to be for the primary election: September 2, 1997 for \$ 1,000 and December 16, 1997 for \$2,000.

The 1998 contributions remain for the general election for each candidate.

I apologize for the length of time to respond to your request, but as I mentioned on the telephone many of the files were in offsite storage and had to be retrieved, as well as the individual to monitors our contributions was out of the office.
