
Dear Ms. Burkhart:

This is in response to your letter dated December 8, 1999 regarding the Blue Shield of California Political Action Committee's ("BSC PAC") contribution to the Feinstein 2000 primary election campaign in the amount of \$3,000 dated 4/23/99. We concur that the BSC PAC inadvertently exceeded the contribution limit of \$1,000 per election for a non-multi-candidate political committee.

In order to correct this error, we have received a refund of \$2,000 from Feinstein 2000 (please see copy of check attached). This refund brings our net contribution to \$1,000, which is within the allowable limit. Our first quarter 2000 report will reflect the receipt of this refund.
