Dear Ms. Brees:

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Schedule A of your report (pertinent portions attached) discloses a loan receipt which appears to exceed the limits set forth in the Act. 2 U.S.C. §441(a)(f) precludes a committee from accepting contributions from a person in excess of \$5,000 per calendar year. For your information, a loan to a committee is a contribution to the extent that it remains outstanding. 11 C.F.R. §100.7(a)(1)(i)(B)

The Commission notes the partial transfer out of the excessive portion of the loan; however, the loan receipt still appears to be excessive.

If the contribution in question was incompletely or incorrectly disclosed, you should amend your original report with clarifying information. If you have received a contribution that exceeds the limits the Commission recommends that you repay the excessive amount. Please inform the Commission immediately in writing and provide a photocopy of your repayment check. Any repayment should be disclosed on a supporting Schedule B for Line 26 of your next report.


Although the Commission may take further legal action concerning the acceptance of an excessive contribution in the form of a loan, endorsement or guarantee, your prompt action will be taken into consideration.

-The Detailed Summary Page, on Line 18 Column A of your report, discloses \$119,482.03 in transfers from the non-federal account for joint activity for the reporting period. However, Line 21 (a)(ii) Column A discloses \$114,234.00 as the non-federal share for joint activity for the reporting period. While the non-federal account is permitted to transfer funds to the federal account for shared activity, transfers for shared activity must be made within a 70-day time period: no more than 10 days before or 60 days after the payment to the vendor. 11 CFR §§106.5(g)(2) and 106.6(e)(2) Please clarify the nature of the transfers-in from the non-federal account.

The Commission recommends that you immediately transfer back to the non-federal account, the total excessive amount which was received by your federal account outside the 70-day time period. Although the Commission may take further legal action concerning this prohibited activity, your prompt action will be taken into consideration.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
