1. In response to your letter dated October 24th, 2014, the Pre-General FEC Form 3 report of receipts and disbursements was certified mailed to the United States Senate on October 23rd, 2014. Additionally, the report is on the Federal Elections Commissions website to view.

2. In response to your letter dated September 16th, 2014, the July Quarterly FEC Report was privously amended on 10.15.2014 to reflect the correct date coverage. Additionally, the amended report resolves the column B total issues that are in question. The negative cash of hand is related to outstanding checks that had been processed, but not yet cashed. Also, Malcom Forbes' \$2,600 contribution on 5/19/2014 and Camile Kampouris' \$1,000 contribution on 5/21/2014 that were reported as 48-hour notices are reported on schedule A with the amendment.

3. In response to your letter dated March 24th, 2015 the July Quarterly FEC Report has been amended to reflect the correct beginning cash balance that equals the ending cash balance for the 12 Day Pre-Primary Report. (Same amended report as above.)

4. In response to your letter dated March 24th, 2015 the October Quarterly FEC Report has been amended to reflect the correct beginning cash balance that equals the ending cash balance for the amended July Quarterly FEC Report. (Same amended report referenced in numbers 2 and 3.) Additionally, the erroneous discrepancy with the outstanding debt has been revised to reflect the correct amount, \$11,788.59.

5. In response to your letter dated March 29th, 2015 the 12 Day Pre- General FEC Report, the two contributions from Bernard's Inn were reported as In-Kind memo entries. The \$2,600 on 10/7/2014 was reported as an In-Kind contribution from Marlene Gabriele for food and beverage purchase for an event at Bernard's Inn, the other \$1,274.67 was reported as an In-Kind contribution from Joseph Gabriele for food and beverage purchase for an event at Bernard's Inn.

6. In response to your letter dated March 29th, 2015 the 30 Day Post- General FEC Report has been amended to reflect a zero cash balance and the corrected schedule D debt amount. Additionally, Alexander Gologovski's, Tatnall Hillman's and Linda Whipple's excessive contributions have redesignated or refunded on the amended report to meet the FEC individual threshold contribution limits. Alexander Gologovski's missing 48-hour report for his \$1,000 contribution on 10/28/2014 is actually Lydia Gologovski's 48-hour report filed for her \$1,000 on 10/28/2014. Richard Danker's \$1,000 contribution on 10/22/2014 was erroneously reported as a 48-hour notice, when in fact this was for Richard Hough's missing 48-hour notice report for his \$1,000 contribution made on 10/22/2014. American Conservative Union's \$2,500 contribution on 10/22/2014 was erroneously reported as a 48-hour notice, when in fact this was for Prosperity Action Inc PAC's missing 48-hour notice report for their \$2,500 contribution made on 10/22/2014. Reports have been amended to reflect these changes.


Finally, any subsequently reports that may have been in issue due to the amendments have been amended to reflect those changes and corrections.


