On February 8, 2016 the PAC became affiliated with Tea Party Forward (C00608166). Tea Party Leadership Fund and Tea Party Forward agreed to combine operations through Tea Party Forward, with Tea Party Leadership Fund discontinuing activity. As part of this consolidation, Tea Party Leadership Fund has transferred the following debts to Tea Party Forward: Campaign Solutions - \$22,384.58 Campaign Solutions - \$6,110.56 Total - \$28,495.14 Also note, the committee entered an Audit Adjustment of \$1,675.14 to correct an unidentified error in entry during the operating period of the PAC.
