To Whom It May Concern:

Please find enclosed the following amended Form 3Xs for the TranSystems Corporation PAC (FEC ID 00433672) (the "PAC"). Below is an explanation of why the amended reports are being filed.

Amended Quarterly Report – April 15, 2008: The PAC failed to include a \$500 non-federal disbursement to the Lynch for Congress Committee on its Quarterly Report. This disbursement is included in this Amended Quarterly Report and is itemized on Schedule B.

Amended Quarterly Report – July 15, 2008: Due to a clerical error, the PAC listed \$2,700 in total disbursements during this reporting period. The PAC actually had \$2,000 in disbursement. This clerical error has been corrected in this Amended Quarterly Report. The PAC also incorrectly listed disbursements to federal candidates in line 29 of the Quarterly Report. Those disbursements have been moved to line 23 in this Amended Quarterly Report.

Amended Quarterly Report – October 15, 2008: Due to the errors in the previous Quarterly Reports, the PAC's third Quarterly Report in 2008 was incorrect. This Amended Quarterly Report appropriately accounts for the amendments made to the previous two Quarterly Reports. The PAC also incorrectly listed disbursements to federal candidates in line 29 of this Quarterly Report. Those disbursements have been moved to line 23 in this Amended Quarterly Report.

Amended 12-Day Pre-Election Report: During this reporting period, a PAC disbursement check was returned by a non-federal candidate. The PAC failed to include the returned check in the 12-Day Pre-Election Report. This Amended 12-Day Pre-Election Report (i) accounts for the returned check, (ii) accounts for errors in the previously filed Quarterly Reports, (iii) moves disbursements to federal candidates during this reporting period from line 29 to line 23.

Amended 30-Day Post-Election Report: The PAC incorrectly listed disbursements to federal candidates in line 29 of the 30-Day Post-Election Report. Those disbursements have been moved to line 23 in this Amended 30-Day Post-Election Report. This Amended 30-Day Post-Election Report also accounts for errors in the previously filed report in 2008.
