This letter is in response to the enclosed letter, and as a follow up to our phone conversation this morning regarding contributions to Representative Ike Skelton.

I have enclosed an amended October 15 Quarterly Report. This amendment reflects the \$1,000 contribution on July 23, 1996, toward the general election, rather than the primary election. The primary disbursement box was inadvertently checked instead of the general disbursement box, which all the contributions were during this reporting period.

This correction should now reflect a total of \$4,500 combined contributions towards Representative Skelton's primary election, and a total of \$3,750 combined contributions towards his general election.
