To Whom It May Concern:

Attached please find a second amendment to the Committee's July Quarterly report.

This amendment modifies pages 7, 8, and 9 of Schedule A, to reflect that receipts consisting of loans from the Candidate to the Committee were from cash advances on a credit card owned by the Candidate. This amendment also modifies Schedule C, in pages 27 through 37, to similarly reflect that the source of funds loaned by the Candidate to the Committee were from cash advances on a credit card owned by the Candidate, and that the credit card is issued jointly to Charles E. Hardy and Susana Gonzalez. Finally, this amendment adds supplementary information in Schedule C-1 to disclose that the source of cash advances itemized in Schedule C is a credit card issued to the Candidate by Chase Bank. This amendment also contains a modified page 1 to FEC form 3. No other pages of the Committee's original April Quarterly report, as modified by our first amendment dated 10/04/2014, are affected by this amendment.

I as Treasurer mistakenly assumed that the loans made by the Candidate to the Committee on the dates indicated in Schedule C from 2/5/2014 through 6/27/2014 were from the Candidate's personal funds; I did not learn until this time that the origin of the funds was from credit card cash advances. I understand that the Committee is required to disclose the source of any funds borrowed by the Candidate and subsequently loaned to the Committee, and hope that this amendment complies with FEC reporting requirements.

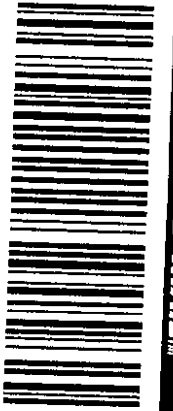

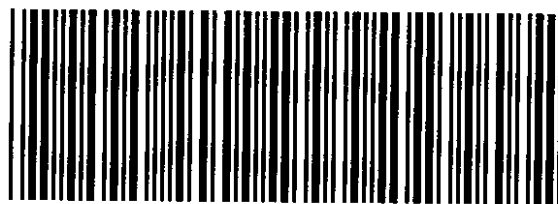

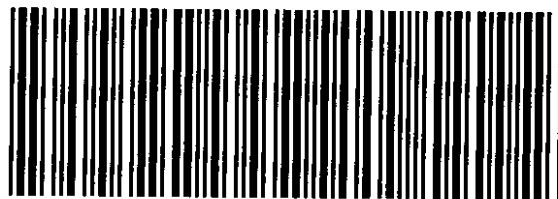
