This letter is in response to your September 18, 2007, inquiry regarding the Moving America Forward PAC Mid-Year Report for the time period 1/1/07 through 6/30/07. In the inquiry, three items were addressed. Please see the below response to each item:

1. All expenditures for "Event Expense", "Fundraising Consultant", "Catering" and "Fundraising Event" on Schedule B were made for general PAC fundraising purposes and not in behalf of any particular candidate.
2. The expenditures for "Fax", "Postage" and "Printing" disclosed in Schedule B did not contain express advocacy for any particular candidate.
3. Regarding Administrative Expenses:
  - a. All payments to a person aggregating in excess of \$200 in a calendar year are disclosed on Schedule B supporting Line 21(b) of the Detail Summary Page.
  - b. No expenditures are being paid by a connected organization
  - c. No expenses were incurred but not paid during the reporting period.
  - d. No in-kind contributions were provided during the reporting period.
  - e. All expenses have been adequately disclosed. No volunteers have provided any services listed as administrative expenses during this reporting period.
  - f. The report did not contain any in-kind contributions. The Detailed Summary Page contains an accurate accounting of contributions to federal candidates.

In response to your 10/1/07 question (per phone conversation with Peggy Gagnon, Asst. Treasurer) concerning utilities, please note that all utilities are included in the rent paid to Capital Associates.

In summary, the original report filed with the FEC is accurate and does not require amendment. I can be reached at 321.779.9223, if you require further information.


