We have learned that a notice of failure to file the 12-Day Pre-General Report of the Freedom Federal, Inc. PAC was sent to the Committee on December 14, 2012. We did not receive a copy of the notice.

The Committee was not required to file the 12-Day Pre-General Report covering the period October 1 to 17, 2012 because it had no activity. The Committee filed a timely 30-Day Post-General Report, but inadvertently dated the report covering the period October 18 to November 26, 2012. The report should have been properly dated October 1 – November 26, 2012. The 30-Day Post-General Report also reflected no committee activity except for a nominal receipt of interest. All subsequent reports were timely filed.

A report has been filed for the issue raised in your December 14, 2012 communication. Accordingly, the dates on the 30-Day Post General Report correctly reflect the proper time frame.
