In researching the exessive contribution issue raised by the RFAI, it became apparent that the \$10,000 check for the two \$5,000 contributions to the Debbie Wasserman Schultz Campaign was prepared, reported on the FEC reports, but never sent. Accordingly, this check is being VOIDED and the reports are being amended to properly reflect this.
