This letter is in response to your letter to me dated March 27,1996, regarding questions about the amounts listed in our last PAC report for the period referenced above.

As I was in the process of preparing that report in January of this year, I became aware of some minor errors in my totalling of bank deposits and bank charges dating from October of 1993. In filing the 7/1/95 - 12/31/95 report I relied on correct information provided by my bank as to the starting balance for that period, and all other information in that report is also accurate.

I have now completed a detailed review of our prior reports from 7/1/93 through 6/30/95 in an effort to both reconcile PAC records and bank statements for these periods and to identify errors so that proper amendments can be filed with your office. In that review I identified the following errors in prior PAC reports:

### J. Period 7/1/93 - 12/31/93

This report underreported \$872.00 in unitemized contributions to our PAC and did not include \$3.00 in unitemized operating expenditures.

### 2. Period 10/1/94 - 11/28/94

This report overreported \$203.00 in unitemized contributions to our PAC and did not include \$9.00 in unitemized operating expenditures.

### 3. Period 11/29/94 - 12/31/94

This report overreported \$1,00 in unitemized contributions to our PAC and did not include \$3,00 in unitemized operating expenditures.

Accordingly, I have prepared the enclosed amended reports to correct the previously filed reports for these periods. I have also enclosed amended reports for all other periods for which reports were filed during the period from 7/1/93 through 6/30/95 to correct the Cash on Hand and Year to Date summaries included in those reports to be consistent with the corrections made for the three periods listed above.

Please note that no reporting errors were made in connection with contributions made to candidates or committees by our PAC, and that no reporting errors were made regarding itemizable contributions received or itemizable expenditures made by our PAC. As our PAC Treasurer, I do regret the errors that were inadvertantly made, and I have revised my procedures for reconciling bank statments with our PAC records to ensure that no future errors are made.
