We have amended the 2012 October Quarterly Report in response to the April 2, 2013 RFAI letter that we received regarding 24 hour IE Reports filed by our committee during the reporting period and subsequent entries detailed on Schedule E, supporting Line 24. In response to point 1 of the letter; we incorrectly included payments made for regular PAC administrative expenses to American Airlines, Chick-fil-A, Chipotle, CVS, Five, Hard Times, Jimmy John's, Motel 6, Pizza Boli's, Rein Tong Thai, Trader Joe's, Boston Market, Subway and Lime Fresh Mexican Grill as independent expenditures on our 24 Hour Reports filed from 8/1/12 to 8/13/12. We received additional information from the FEC and adjusted our 24 hour IE reporting to only include those expenditures that met the definition of an independent expenditure. In addition, we have added additional itemized disbursements on Schedule E for Line 24 for the expenditures made to 'CAV call agent salary' and 'NorthStar Campaign Systems' so that they now correlate to the 24 hour reports filed by the Committee. Please also note that the independent expenditures originally disclosed to 'CAV full-time staff' for Grantham and Schweikert are now showing with 'Edward King' as the updated payee.
