Because the F.E.C. called expressing concern that these letters are not being delivered, and because your address is being used on the material that your office is compiling and furnishing to the F.E.C., they want to be sure that this letter is being written to your office, by me, advising you and your office staff that any such correspondence from the F.E.C., addressed to me, for the Friends of Mount Sinai Medical Center PAC, must be forwarded by regular mail, in a separate envelope addressed to me, at my office address (1175 N.E. 125th Street, Suite 102, North Miami, Florida 33161).

Frankly, you can open the letters and do what needs to be done in regard to the material and/or requests that are contained in the correspondence. However, I, as Treasurer, am held responsible for replying to such inquiries, and I cannot respond unless I get the letter.
