There were two (2) contributions made by CMSA that would have caused a discrepancy in the opening and closing balances of our filing. In 2006, we made a contribution to Capito for Congress via check. However, the check was not cashed. Further, in the 2Q of 2007, a contribution check was send to Baker for Congress - this check was not cashed as well. Both checks were reissued in the 3rd Q of 2007. In order to account for this adjustment, we amended the previous report and indicated the appropriate negative entries in order to balance the account. Please note that the closing cash for the 6/30/07 filing and opening cash for the 12/31/07 is equal to \$132,082.80. As of 10/16/08, subsequent check that was reissued for BAC PAC (Congressman Baker) was not cashed, and therefore will be voided. Please let us know if you require any further information. We added the Calendar YTD total from our previous report to the current total this period figure and came up with the correct column B totals on the report.
