The enclosed documents address the issue mentioned as Item 2 in a letter the Oklahoma Leadership Council, Identification Number C00167213, received regarding their February Monthly Report (01/01/2011-01/31/2011).

As that report notes, on February 20, 2011 it was determined funds from a state pac were erroneously deposited into the federal account. The employee who handled the banking at that time was asked to transfer the funds to the state account on February 22, 2011. Upon investigation it was determined the transfer was not made.
