This letter is in response to your recent request for additional information concerning the above referenced report.

1. Last Minute Reports

Due to a clerical oversight, the Committee was unable to report some of the contributions received on 10/26/00. The Committee will establish an additional review process for the next election.

2. Schedule C

Attached is an amended Schedule C correcting a typographical mistake. The correct due date of the loan reported is 09/24/07, not 09/24/97. The terms of the loan comply with the Commission's regulations; it is not a prohibited contribution.

3. General Election Contributions

Contributions received by the Committee between 11/08/00 and 11/10/00, one to three days after the 11/07/00 General Election date, are appropriately attributed to the General Election. As you have noted in your letter, the Commission's regulations (11 CFR §110.1(b)(2)(ii) and 11 CFR §110.1(b)(6)) require a contribution not designated in writing to be attributed to the next election after the contribution "is made." A contribution "is made" when the contributor relinquishes control over the contribution, either by delivering the contribution to the committee or its agent, or mailing it. The Commission's regulations require the Committee to report on its disclosure reports the date the Committee actually receives the contribution (11 CFR §104.3(a)(4)(i)). Committee records indicate that the contributions received between 11/08/00 and 11/10/00 were made prior to the General Election.
