Dear Mr. Bennett:

Huck PAC (FEC ID# C00448373) is in receipt of your Request for Additional Information dated August 22, 2008, referencing our July Quarterly Report (4/1/08 - 6/30/08).

- With respect to the expenditures identified in Item 1 of your letter, the Committee responds as follows:

The payments included in the report that were labeled as "Fundraising Expense" were all related to fundraising activities on behalf of the Committee, and not any specifically identified federal candidate. Therefore, no disclosures are required with respect to lines 23 and 24 and no amendments are necessary for these items.

- With respect to the expenditures identified in Item 2 of your letter, the Committee responds as follows:

Payments labeled as "Direct Mail," "Media Consulting," "Postage," "Printing," and "Printing Expense" were all related to the Committee's activities and were not undertaken on behalf of any specifically identified federal candidates. These expenditures did not contain express advocacy and did not constitute voter drive activity and therefore do not qualify as either an in-kind contribution or an independent expenditure. Therefore, no amendments are required with respect to lines 23 or 24 of the July Quarterly Report. Any public communications that, while not constituting express advocacy, referred to a federal candidate, were reported on line 21b of the July Quarterly report filed on July 15, 2008.

- With respect to the expenditures identified in Item 3 of your letter, the Committee responds as follows:

In addition to the printing and postage expenses addressed above, the Committee also incurred and paid several overhead/administrative expenses including rent, telephone, computer services, utilities, salaries, and office supplies. All payments to one vender or person which in the aggregate exceeded \$200 were properly disclosed on Schedule B. A summary of these expenses is attached. In addition, all expenses incurred were paid and did not result in any outstanding debts or obligations other than those indicated on Schedule D of the original filing.

Finally, there were no other goods or services provided to the Committee that are subject to the in-kind disclosure requirements.
