
Dear Ms. Lewis,

We are in receipt of your Request for Additional Information dated October 15, 2008. After reviewing your request and the campaign finance report it relates to, we've determined that the missing information was the result of a technical difficulty. Although the file we originally attempted to upload to the FEC's servers contained all of the information you are now requesting, the final 700 or so pages of the file failed to upload at that time. This resulted in the information you've requested never making it to the FEC.

We have asked our vendor to prepare another amendment to our M5 report. Once that is prepared, we will attempt once again to upload the file to the FEC's servers. We're confident that the file will upload successfully this time, just as our report files routinely do. We will check the resulting filing closely to make sure all of the information has been submitted to the FEC.
