

Dear Ms. Reynolds:

Please note that in the attached "Mid Year Report" the "Cash on Hand" for January 1, 1997 (See Summary, Line 6 (a) of Reports of Receipts and Disbursements) is reported as \$5,350.00. This figure represents a \$4,200.00 increase over the reported "Cash on Hand at Close of Reporting Period" (Line 8 (a) and (b)) reported in our 1996 Year End Report. The reason for this discrepancy is that a \$4,200.00 disbursement made to "Toricelli for Senate" on 10-30-96, and reported in the Itemized Disbursement page of our 1996 Year-end Report, was never cashed. Upon investigation, the ANC-PAC learned from the Toricelli for Senate Campaign that the check had been received but lost, and as a result never cashed. Arrangements have been made with the campaign to rectify this situation and will be reflected in our next filing.
