Our committee has low overhead and is run by volunteers. We do not have any employees that spend more than 25% of their time on FEA and we have no wages for schedule B. We have wages for schedule H for an administrative employee who spends less than 25% of their time on FEA. The California Republican Party's (CRP) accounting department has confirmed with us that the payments of Levin funds to our committee were allocable expenses they paid to us. Since its FEC audit the CRP has paid allocable expenses with two checks, one federal and one non federal, per FEC instruction. The bounty payments from the CRP were also deemed consideration for services rendered and not contributions by the FEC informally. The CRP bounty payments received by our committee were paid and received in this fashion. Therefore they have been reported as Miscellaneous Receipts on Schedule L and based on past correspondence between the FEC and the CRP, no corrective action is required.
