Each person who has contributed in excess of \$200 since January 1 should be identified by name, address, occupation, name of employer, amount of contribution, and aggregate total on Schedule A. 11 CFR \$110.1(k) Please amend your report by providing the omitted information.

-Schedule A of your report discloses \$1,550.00 in in-kind contributions to your committee from individuals. Please be advised that in addition to disclosing in-kind contributions as a receipt on Schedule A, the value of the in-kind contributions must be added to the operating expenditures total on Line 21(b), in order to avoid inflating the cash-on-hand amount. Il CPR \$104.13(a)(2) Please amend your report by itemizing the in-kind contributions on Schedule B, supporting Line 21(b) of the Detailed Summary Page.

-Please identify the name and address of the payee for the in-kind contribution(s) disclosed on Schedule B for Line 23.
