This letter is in response to your inquiry dated October 13, 2000 regarding the July Monthly Report filed by CULAC. The questions raised concern contributions to candidates for the Primary election which were disbursed after the election date. Those questions have prompted the following actions. In regards to the first recipient, Friends of Robert C. Byrd, the contribution dated 6/2/00 in the amount of \$1000 was allocated to the wrong election. The contribution has been redesignated to the candidate's 2000 General from the Primary. A copy of the letter notifying the committee of that change is attached. An amendment to the July Monthly Report is being filed reflecting this redesignation.

Regarding the second recipient, Hayes for Congress, a refund is being requested for the contribution dated 6/14/00. Attached is a copy of that request.
