This letter is prompted by the Commission's preliminary review of the report referenced above. 1. Schedule A, supporting Line 12 of your report discloses transfers from The Founders Committee, that appear to be received through joint fundraising efforts. However, The Founders Committee is not disclosed as a joint fundraising representative on your Statement of Organization. Please amend your Statement of Organization to disclose the joint fundraising representative as an authorized committee of the candidate or amend your report to provide clarifying information. (11 CFR 102.2(b)(1)(i) and 11 CFR 102.17(b)(2))

- Please be advised that the FEC Committee ID numbers for the following contributions from political committees appear to be incorrect: American Political Action Committee (C99002396). Use of incorrect FEC Committee ID numbers may create difficulty in identifying the contributing committee for the public record. (11 CFR § 104.3(a)(4))

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. Requests for extensions of time in which to respond will not be considered.
