This letter is in response to your recent request for additional information concerning the above referenced report.

1. Schedule C

Attached is an amended Schedule C correcting a typographical mistake. The correct due date of the loan reported is 09/24/07, not 09/24/97. The terms of the loan comply with the Commission's regulations; it is not a prohibited contribution.

2. Contributions

The Committee has not received an excessive contribution. The contributions from Tina Wu received in November 1998 were designated by the contributor to the 1998 Primary Election debt retirement. These designations were reported in amendments the Committee filed in January. Please see Schedule A for Line 11(a), page 20, of the amended report.
