Enclosed is the American Baker's Association Report of Receipts and Disbursements for the period of October 16, 2002 - November 25, 2002.

As you discussed with Robb MacKie of my staff this morning, we have discovered that a couple of receipts from contributors to BreadPAC were inadvertently left off of our previous Report filings. We are currently undertaking an internal review to correct this oversight.

Per your instructions to Mr. MacKie, we are listing these BreadPAC receipts in this reporting period, but with the correct receipt dates from earlier this year. We are still in the review process to rectify an outstanding receipt of less than \$500 and will file the appropriate amendment at the earliest possible date. For this reason, while the BreadPAC bank account has sufficient funds covering disbursements to candidates, our current report indicates a small negative balance.
