Dear Ms. Daughtrey:

The American Association for Geriatric Psychiatry Political Action Committee (AAGP-PAC) received your notice dated May 23, 2008 requesting additional information regarding a disbursement totaling \$3,062.50 on Schedule B of the May Monthly Report.

Our review of the May report revealed that a reporting error was made. This disbursement was not a transfer between AAGP-PAC accounts. It was a disbursement to the American Association for Geriatric Psychiatry (Association). The Association had paid an outside vendor for expenses related to an AAGP-PAC fundraiser and this disbursement was to reimburse the Association for those expenses. An amended May Monthly Report for the period April 1 through April 30, 2008 was electronically filed on June 11, 2008 to correct this error.

However, upon filing of the June Monthly Report, it was realized that the amount of the reimbursement to AAGP reported in the May Monthly Report was also incorrectly reported. Therefore, a second amended May Monthly Report was filed today to also correct the amount of the expense reimbursement to \$3,202.50.
