
Enclosed please find amended FEC Form 3X reports for:

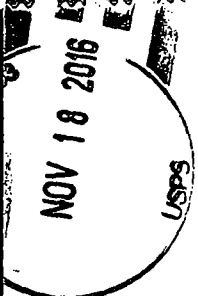

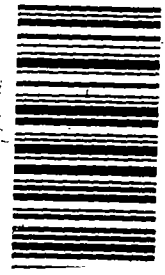
