3, 255 individual Sheriff Deputies employed by 65 different parish sheriffs' offices in Louisiana have contributed various small amounts per month via payroll deduction into the PAC (commonly \$5 per month but contribution amounts range from \$0.93 to \$51 during this reporting period); however, there is no individual Deputy that has exceeded the \$200 aggregate itemization threshold during this reporting period. The total contributions for this reporting period has been revised to \$20,358.50 due to a \$780 staff clerical error that inadvertently added to the Report total some sheriff contributions that did not qualify for deposit since this is a combined federal/state account PAC—deputies contribute to the federal account and sheriffs contribute to the state account. Those ineligible sheriff contributions were returned without depositing them into the federal account and therefore the deputy contribution total has been revised downward to \$20,358.50. —James S.
