RRD Donnelley is making a one time adjustment to the January 1, 2011 beginning cash on hand; we have completed a thorough review of internal processes and realized there was a discrepancy between some previous payroll deposits and the amounts being reported on the FEC disclosure filings. We were not able to pinpoint a specific event that caused the discrepancy. Instead, it seems it may have been an accumulation of small unintentional errors over a period of time. As a result, we are submitting an adjustment to our Cash on Hand and submitting all subsequent amended filings. This discrepancy has been corrected and processes have been put in place to ensure these errors will not occur in the future. In addition to these payroll discrepancies, we will be reporting a number of checks that are still outstanding dating back several years.
