

Kevin Midbust for Freedom FEC MAIL CENTER It's a Free Country

My beloved Federal Election Commission,

As you already know, my name is Kevin Midbust. I am one of the candidates for the 4th Congressional district of Washington State. I received an email from you stating that I failed to disclose the full address of my committee. I apologize for that. Going back over my filing form, I found out that I did in fact fail to input an address. The amendment will be with this letter. You then proceeded to inform me that if I do not supply the address information, that my committee may be subject to an audit and that some form of enforcement action will be taken against my committee. Now, we have an interesting situation here. I am unsure of how you would actually be able to audit my committee if it has no address for you to look up to find it. I expect, though, that yon would just use the address of my treasurer, who is me. Of which I am also the Custodian of Records and the Designated agent. Common sense would perhaps indicate that my committee is made up of me, myself, and I, so common sense would likely dictate that the address of my committee is the exact same as the address of myself. Of which I input my address 3 times on that form I filed. That is without the return address that I also wrote on the envelope that I mailed the form in to you with. So really, you have my address 4 times.

Really, it's understandable that I missed a little detail like that. The anxiety of trying to fill those forms out right and being worried about being audited, fined, or jailed for forgetting to put an address on a piece of paper makes it very possible that mistakes will be made. I have gotten over it though. I am a person who likes to do things myself, its very fulfilling to me, so if you guys at the FEC feel I am incapable of correctly filing the information you need, feel free to send someone to help me out. All of the rules and regulations are difficult to follow and understand. Plus, I am the only person in my committee so perhaps someone at the FEC would like to be my first member that makes sure the FEC gets all the information it wants? I wouldn't be paying you, I already pay taxes so you would essentially be paid to do the job you are doing.

Lets also not forget about your website. I don't really understand why you have a website and an email system, yet I have to file through the mail. Or perhaps it is understandable, I am guessing the money that was going to go towards an update on your website went towards trying to fix the Healthcare.gov website.

I don't understand, though, how the FEC is even allowed to exist. I have read through the requirements to run for elected office, and nowhere does it say I have to create a committee to run for office. Nor does it say that I can only take a maximum of \$2600 from individuals as donations. Nor does it say that I have the right and moral authority to disclose the private information of the individual donors. It is not my committee running for office, it is me.

The reality is that all money I receive in donations and all money I spend are personal expenditures not subject to any reporting requirements. I am minning for office for myself, for my benefit, it is no different than applying and interviewing for a job. I do not need to disclose to my employer who paid my college tuition, or how much I paid for my car which I used to drive to the interview. I do not need to disclose to my employer the money I spend on education or products that help me become more qualified for the job.

I work at a popular drug store chain. One thing all of us at the store understand is a law known as HIPPA. You see, basically this law requires everyone that works at the store to protect the private information of individuals who shop there and get their medications there. We are not allowed to disclose their private information outside of what needs to be disclosed to do business. This law is so strict that just having the name and/or number of an individual written on a piece of paper behind the register is a violation and can result in fines or other punishments to the business and workers that work there. If people leave the little photo card in the photo machine that has their name and phone number on it, we have to dispose of the photo card properly, not just throw it in the trash. Otherwise we're subject to fines or other enforcement actions. We literally have to have about 4 different kinds of garbage cans to make sure we dispose of this information properly. But for some reason, when it comes to donations to candidates, all the sudden it is OK to plaster the same private information of individuals who make donations all over the Internet. At most individuals are responsible for deciding whether or not to disclose their private information to the public in any media and any form.

I suppose I am an high priority target. A retail shift supervisor. Wouldn't want to bother those experienced politicians that get paid 10 times more than me a year while also making that per month in donations. Yeah, they make and get more money than I do but still beg for more while I don't really care if I get donations or not. I mean, who knows what will happen if regular people like me are allowed to get elected. We wouldn't want people to be free to throw themselves into election races now would we?

I am not worried about the whole filing and disclosure thing though. I don't even really know when, or If I will spend or receive \$5000 to actually require me to file with the FEC, I merely filed just to be ahead of the game. Honestly I read through the rules and regulations and I still don't really know how to determine whether something I may purchase or receive will need to be filed which is why, if you guys there at the FEC feel that I may not have filed something that should have been filed, you guys are free to send someone to be my official treasurer, otherwise I wouldn't mind if you just left me be to run my campaign instead of asking me to deal with this petty bureaucracy.
