

Issue #1) Enclosed is a schedule H2 that the IL Republican State Committee is filing to disclose the allocation ratio for the fundraising event held at the Palmer House Hilton, on March 6, 1995. This ratio was calculated using the "funds received method", pursuant to FEC requirements. Please note that the 4/12/95 transaction of \$26,039.57, reported on Line 21A of the disbursement schedule H-4, batch #7, page 46 of 79, has a non-federal transfer of \$20,831.66 listed on Line 18 of the receipt schedule H-3 on page 7 of 9. This transfer is computed at approximately an 80/20 percent ratio. However, when taken with the total disbursements for this event, this transfer falls within the acceptable 75/25 percent ratio level, which is reported on the schedule H-2 we are submitting. The other disbursements, relating to this event, which were solely paid with federal dollars, are reported on Line 21B, schedule B, pages 1 and 2. These disbursements are as follows:

Issue #2) There are several expenditures made in 1995 which are directly related to the 1994 election cycle and allocation schedule having a 13% Federal-Share ratio for administrative expenses. These expenses were grouped into two batches for



ALLOCATION RATIOS FOR INDIVIDUAL FUNDRAISING EVENTS, EXEMPT ACTIVITIES, AND SHARED DIRECT CANDIDATE SUPPORT APPEARING ON THIS REPORT.

Methods of allocation:

I. **FUNDRAISING** activities are allocated using the "funds received method" where the federal proportion of expenses must equal the federal proportion of monies raised.

II. **EXEMPT** activities are allocated using the "time and space method" where the federal proportion of disbursements is based on the proportion of time or space devoted to federal candidates.

III. Shared **DIRECT CANDIDATE** support activities are allocated according to benefit expected to be derived, where the federal proportion of disbursements is based on the benefit derived by federal candidates from the activity.
