Dear Mr. Whyrick:

This letter is in response to your recent request for additional information concerning the above referenced report.

1. Schedule C

Attached is an amended Schedule C correcting a typographical mistake. The correct due date of the loan reported is 09/24/2007, not 09/24/1997. The terms of the loan comply with the Commission's regulations; it is not a prohibited contribution.

2. Earmarked Contributions

Attached are Memo Schedules A for Line 11(a) and 11(c) (Itemized Receipts) that list contributions received through an intermediary or conduit. Pursuant to guidance from the Information Division of the FEC, the schedules identify each intermediary and list each date the Committee received contributions through an intermediary and the total amount received through the intermediary on each date. The itemized contributions received from individuals contributors and political committees received on each receipt date are also listed. In each case, the date the contribution was received by the conduit and the date the conduit transmitted the contribution to this Committee is the same.

As you indicated in your letter, these itemized contributions were reported on the July Quarterly Report and the entries indicated they were received through the conduit. The Committee wishes to state for the public record that these earmarked contributions are not contributions from the intermediary or conduit, but are contributions from the individuals and political committees listed who have designated their contributions to the Committee and used the intermediary to transmit the contributions to this Committee.

3. Primary Election Contributions

Contributions received by the Committee on 5/17/00 and 5/19/00, one and three days after the 5/16/00 Primary Election date, are appropriately attributed to the Primary Election. As you have noted in your letter, the Commission's regulations (11 CFR §110.1(b)(2)(ii) and 11 CFR §110.1(b)(6)) require a contribution not designated in writing to be attributed to the next election after the contribution "is made." A contribution "is made" when the contributor relinquishes control over the contribution, either by delivering the contribution to the committee or its agent, or mailing it. The Commission's regulations require the Committee to report on its disclosure reports the date the Committee actually receives the contribution (11 CFR §104.3(a)(4)(i)). Committee records indicate that the contributions received on 5/17/00 and 5/19/00 were made prior to the Primary Election.
