Dear Antoinette Kitchen:

The amount of \$38,586.98 for Receipts/Contributions that we reported on page 2, FEC form 3X, line 11(a)(iii), column A (Total Contributions) was reported correctly on both our original report for the period 10/19/00-11/27/00 and our amended report for the same period.

The confusion is the result of our internal reporting procedures, which I believe have improved with electronic filing.

On our original report to the FEC for the period ended 11/27/00 we incorrectly reported accumulated receipts of over \$200 from 136 individuals on 11/30/00. That date was incorrect, but in that group there were eight individual whose contributions we received on 11/01/00 and not 11/30/00 as was originally reported.

Our amended report corrected the 11/30/00 receipts of 128 individuals in the amount of \$4,151.56 and correctly reported that amount as unitemized on line 11 (a)(ii) since it was originally incorrectly deducted from the "unitemized" on our original report.

We also corrected the date of receipt to 11/01/00 for the eight other individual—their contributions totaled \$350.05 for the period and remained in the amount on line 11 (a)(i)- "itemized"

Of course, as you can see the two amounts total the \$4,501.61.


I believe that the amended report is correct as filed, but our letter of explanation accompanying the amended report was inadequate.

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-In a letter you state, "In our original report, we erroneously reported amounts that were not received until after the cut-off date for this report of 11/27/00." However, you have reduced Line 11(a)(i) by \$4,151.56 and have increased Line 11(a)(ii) by this exact amount of \$4,151.56. In addition, the amount of contributions originally reported outside of the reporting period totals \$4,501.61. Please amend your report to clarify these discrepancies.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
