Dear Mr. Dobi:

This statement is in response to the Commission's letter dated October 29, 2019 regarding four items.

First, regarding contributions from business entities, our Committee has safeguards in place to ensure that all contributions are made by eligible contributors only. If the contributor has not verified that they are either a partnership or a sole proprietor (and not taxed as a corporation) within the permissible timeframe, the Committee will refund the contribution in a timely manner as will be reflected on the upcoming 2019 Year-End Report. The Committee has confirmed that the rest of the contributors used permissible funds as will be reflected in the Amended 2019 October Quarterly Report.

Second, the Commission's letter requests clarification on contributions from fifty-two (52) contributors disclosed on the Original Report that appear to exceed federal contribution limits. As described below, all of those contributions were properly and timely redesignated, reattributed, refunded/charged back, or returned to a joint fundraising committee ("JFC") in which the Committee participates for proper reallocation, as will be reflected on either the Amended 2019 October Quarterly Report being filed concurrently with this response ("the Amended Report") or the Committee's upcoming 2019 Year-End Report:

- Twenty-four (24) of the contributors had their excessive contributions returned to the joint fundraising committee (Perdue Victory, Inc.- C00571620) from which they came, to be reallocated to other JFC participants.
- Sixteen (16) contributors' contributions were redesignated to another election.
- Seven (7) contributors' contributions were either refunded or charged back to the contributor's credit card.
- Five (5) contributors' contributions were reported with incorrect election designations due to a clerical error.

In regard to the contributions that appear to be excessive from 'Affiliated Committees', these two committees do not appear to be affiliated committees based on their respective Statements of Organization filed with the Federal Election Commission. The Committee has reached out to both committees and have confirmed that these committees are not affiliated.

Third, regarding contributions from LLCs (limited liability companies), our Committee has safeguards in place to ensure that all contributions are made by eligible contributors only. If the contributing LLC has not verified that they are taxed as either a partnership or sole proprietor (and not taxed as a corporation) within the permissible timeframe, the Committee will refund the contribution in a timely manner as will be reflected on the upcoming 2019 Year-End Report. The Committee has confirmed that the rest of the contributors used permissible funds as will be reflected in the Amended 2019 October Quarterly Report.

Fourth, regarding contributions from organizations which are not a political committee registered with the Commission, our Committee has safeguards in place to ensure that all contributions are made with federally permissible funds. If the
