This means that reporting reminders and other mailings concerning changes in the law will no longer be sent to committees through the U.S. mail system. As a result, it is important that every committee update its Statement of Organization (FEC Form 1) to disclose an official (and current) email address.

The Commission recognizes that disclosing a personal email address on a public document may raise privacy concerns. As the agency begins to communicate with committees electronically, keeping that email address current will be essential.
