This letter is prompted by the Commission's preliminary review of the report referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **Failure to adequately respond by the response date noted above could result in an audit or enforcement action.** Additional information is needed for the following **8** item(s):

1. Line 6(a) of the Summary Page represents the total cash-on-hand as of January 1, 2015. Line 6(b) represents the cash on hand at the beginning of the reporting period. These two figures should be the same for the first report of the year. Please clarify this discrepancy and amend any subsequent report(s) that may be affected by this correction. (52 U.S.C. §30104(b)(1) (formerly 2 U.S.C. § 434(b)(1)) and 11 CFR §104.3(a)(1))
2. Line 6(c), Column A and B of the Summary Page does not equal Line 19, Column A and B of the Detailed Summary Page. Please amend your report to correct this discrepancy. (11 CFR § 104.3(c))
3. Your calculations for Line(s) 6(d), Column B appear to be incorrect. Please provide the correct totals on the Summary Page. (52 U.S.C. §30104(b) (formerly 2 U.S.C. §434(b)(7)))
4. Line 7, Column A and B of the Summary Page does not equal Line 31, Column A and B of the Detailed Summary Page. Please amend your report to correct this discrepancy. (11 CFR § 104.3(c))
5. Your calculations for Line(s) 8, Columns A and B appear to be incorrect. Please provide the correct totals on the Summary Page. (52 U.S.C. §30104(b) (formerly 2 U.S.C. §434(b)(7)))

6. Please provide the amount(s) for Line(s) 21(b), Columns A and B of the Detailed Summary Page and amend your report and any subsequent reports that may be affected by this correction. (52 U.S.C. §30104(b) (formerly 2 U.S.C. §434(b)))

7. Please provide a Schedule A to support the amount reported on Line 13 of the Detailed Summary Page. All loans and loan repayments received by your committee must be itemized on Schedule A regardless of the amount loaned or repaid. (52 U.S.C. §30104(b)(3)(E) (formerly 2 U.S.C. §434(b)(3)(E)) and 11 CFR §104.3(a)(4)(iv))

8. Line 21(a) of the Detailed Summary Page discloses allocated federal/non federal operating expenditures during the reporting period. Committees must itemize each allocated disbursement made from its federal account or separate allocation account regardless of the amount. Please amend your report(s) by itemizing the expenditures on Schedule H4. (11 CFR §§104.10 and 104.17)

- For your information and consideration when preparing future filings, please provide separate Schedules A to support each category of receipts disclosed on Schedule A for Line(s) 11(a)(i) and 13. For your next filing, please refer to the instructions for each line when determining the proper categorization(s). (11 CFR § 104.3)

- For your information and consideration when preparing future filings, please provide separate Schedules B to support each category of disbursements disclosed on Schedule B for Line(s) 21(b) and 26. For your next filing, please refer to the instructions for each line when determining the proper categorization(s). (11 CFR § 104.3)

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**


