Amendment resulting from an internal audit initiated by the Committee to correct filed statements of Committee cash on hand (COH). This COH audit revealed that the Committee was not informed or was not aware of a limited number of rebates/cancellations by a credit card processor/conduit. As such, the Committee previously mistakenly reported contributions where funds did not actually reach the Committee, and were not deposited. After consulting with the FEC Reports Analysis section, the Committee is deleting such contributions and filing amendments to accurately reflect COH. No (0) contributions are deleted with this amendment. Amendment also reflects updated credit card processing fees that were reconciled with this internal audit (additional fees reported). This amendment follows amendment of the 2020 Post-General Report and adjusts the summary page information to match that amendment.
