Dear Jan:

Regarding our phone conversation of today concerning the \$10,000 given to federal candidate Steve Chabot, I will try to give you an explanation in sequence.

1. We wrote a check to Steve Chabot for \$5000. on 3/10/94 from our non-federal account.
2. We wrote another check to Steve Chabot for \$5000. on 9/26/94 also from our non-federal account.
3. After I had sent the second check to Steve, I became aware of the fact that I had used our non-federal account for these two checks and that this was a serious mistake.
4. I called the FEC and talked to Ken Davis who said to have Chabot give us \$5000. back and then write him another check from our Federal Account for \$5000 which we did on 10/7/94.
5. As for the check sent to Chabot in March for the Primary, that had been used by him so Ken Davis said to reimburse our non-federal account for \$5000. from our federal account which we did on 10/14/95.
6. We then reported on line 23 of form 3X, \$10,000 in contributions to a federal candidate. On 12/15/94, Ed Ryan called me and said to send in an amended report with form 3X showing \$5000. on line 22 and \$5000. on line 23. This was done and signed and mailed on 12/15/94.
