This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Please clarify all expenditures for "voter contact". In addition, if any of the voter contact activities referenced House or Senate Candidates, they should be allocated accordingly, unless merely incidental to the overall activity. In a portion or all of these expenditures were made on behalf of federal candidates, they should be reported on Schedule B or F, for Line 23 or 25 of the Detailed Summary Page, as appropriate.

-Line 6(c) of the Summary Page of your report discloses a total of \$290,763.17 in total receipts. The sum of the entries itemized on Schedule A, however, indicates the total to be \$258,272.99. Please amend your report to clarify the discrepancy.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
