Dear Ms. Jameson:

I refer to your letters of May 11, 1994 concerning our Mid-Year and Year-End Reports from 1993.

RE both reports: Please refer to my letter of October 29, 1993 regarding clarification of our not allocating administrative expenses, since we did not hold separate federal and non-federal accounts in 1993.

Mid-Year Report: As requested, I am providing herewith a Schedule A to support the entry disclosed on Line 11(c) of the Summary Page. This amount, received from the Republicans Abroad France checking account, represents our share of the proceeds from a joint fundraising event hosted by Democrats Abroad France and Republicans Abroad France with a requested individual contribution of \$50. Of course, funds were only accepted from U.S. citizens and were reported on Line 11(c) as the line most closely corresponding to such a source.

Mid-Year Report: At the time of filing, I did disclose the debt owed to our committee on a separate Schedule D (see copy attached) in support of Line 9 of the Summary Page (and not Line 10 as stated in your letter).

As you suggested in the past, I am sending this as registered mail but ask your understanding for the delay in our response due to the overseas mail in both directions (7 to 10 days for a letter).
