Please be advised that if an in-kind contribution is made in one reporting period and the payment is made in a later reporting period, the in-kind contribution should be reported as a memo entry on Schedule B when the in-kind contribution is made, and on a Schedule D if it is a reportable debt under 11 CFR §104.11. Subsequently, when the payment for the in-kind contribution is made, the report should show a payment on Schedule B and the same payment on Schedule D, if applicable. Please amend your report to clarify this apparent discrepancy.
- 2. On Schedule B supporting Line 21(b) of your report, you have itemized disbursements for which you have failed to include the purpose. Please amend your report to include the missing information. (11 CFR § 104.3(b)(3))

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to
